

Liquor licenses are valid from July 1 – June 30th of each year; therefore the licenses are brought forward each year at this time for renewal. The City has received eight renewal applications for “Class B” Retailers Licenses to sell fermented malt beverages and intoxicating liquors; the name of each applicant is listed above.

Police Chief Chaney has reviewed and recommends approval of the eight applications submitted. City Clerk Bauer has checked for delinquent real estate taxes, personal property taxes, utility payments or any other delinquent taxes for the subject properties and has found that the following property has delinquent billings owed: Untouchable Enterprises (Whiskey Dicks). We also received a letter from the Department of Revenue asking that we deny the issuance of any license to Whiskey Dicks without first contacting their office because Whiskey Dicks does not currently hold a valid seller’s permit at this time.

Staff recommends renewal of Combination “Class B” Retailers’ Licenses to sell fermented malt beverages and intoxicating liquors for seven of the applicants submitted for the period of July 1, 2010 through June 30, 2011 with the exception of Whiskey Dicks. Staff recommends a public hearing on issuance of Whiskey Dicks liquor license.
