ADDITIONAL PET VARIANCE APPLICATION

The City of Altoona's City Ordinance 6.08.075 indicates that no individuals living together in one household, nor any business shall keep more than two (2) dogs and three (3) cats over the age of five months at any household or place of business at one time. The police chief or his/her designee may grant an exemption to the provisions of this ordinance by allowing additional dogs and/or cats where it is determined no nuisance is created. The additional pet variance, if approved, is valid for five (5) years and re-application is necessary if more than two (2) dogs and three (3) cats are kept at any household or place of business at one time.

INSTRUCTIONS to apply for an Additional Pet Variance to keep more than two (2) dogs and/or three (3) cats:

- 1. Complete this form
- 2. Provide written proof of current rabies vaccination certificate*
- 3. Provide a photo of each pet
- 4. Pay \$75 fee to City of Altoona
- Submit the documents listed above and \$75 to: Altoona City Hall, 1303 Lynn Avenue, Altoona, WI 54720.

*Includes the veterinarian's name, date vaccination was given, date the vaccination expires, name of the vaccine manufacturer and the serial #
